It enables you to keep control over the use of your personal data by many retail stores. It also enables you to keep this data up to date with Freedelity clients.

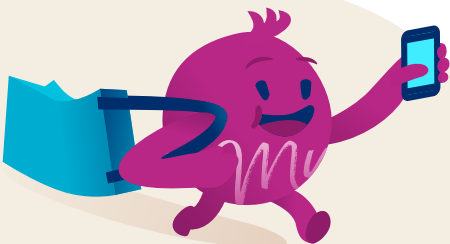

Why have I been asked for my identity card?

The business where you have just done your shopping uses solutions developed by Freedelivery to gather your personal data and keep it up to date, as well as to identify you when you shop, and if applicable, offer you benefits and personalised services such as a loyalty programme, for example.

If the staff of the store you are visiting have asked you for your identity card, **it's just to avoid you having to fill in a paper registration form by hand.**

Must I use my identity card to become a member?

No, using your identity card is not required. Freedelity partner stores and businesses offer alternative registration methods. We recommend that you use your identity card because it enables you to be identified quickly and without confusion, while keeping your personal data up to date.

What data is concerned?

Freedelity automatically gathers the following data from your electronic identity card: **last name, first name, address, place and date of birth and sex**. You can then decide to add (on a voluntary basis) your e-mail address and your mobile telephone number.

This data is then used to enable Freedelity SA clients, including the business you are visiting, to obtain your updated contact details.

If you allow, it can also offer you benefits, send you marketing communications, such as its latest offers, or personalised promotions or save the digital version of your receipts.

How do I access my MyFreedelity account?

As soon as you register, a personal profile is created in your name on the MyFreedelity portal, to enable you to check how your personal data is used.

Access to your personal data is protected and requires authentication. If you have shared your email address with one of Freedelity SA's partner business, you will only need the username and password you were given automatically when you registered.

If you have not yet shared your email address with Freedelity SA or one of the Freedelity customer businesses, you just need to follow the access procedure described below.
